The yearly international meeting for CONTINENTAL LAW

The Summer School, organized by the Civil Law Initiative is an international meeting for those interested in legal culture, whether they are academic scholars, legal professionals or students. For 2018, the Summer School will open on July 2nd, celebrating its 10-year anniversary.

OVERVIEW

Every year, for the first 3 weeks of July, the Foundation organizes courses on Continental Law.

Our ambition is to offer a strong core of knowledge on Continental law, its evolution, its magnitude and influence upon legal and economic dynamics around the world.

In 2017, the Summer School gathered more than 150 participants from more than 50 countries.

EXPECTED AUDIENCE

The Summer School targets anyone with legal knowledge, preferably law-school graduates, teachers and legal practitioners.

The courses are taught in English, Spanish and French. Students need to have a good understanding and use of the language they choose to take the classes in.

TRAINING CONTENT

Each subject is a 10-hour class given in the University Panthéon-Assas (Paris II) by professors from various fields of expertise, but mostly specialized in Continental and comparative law.

Students from every section will have to take one mandatory class :

- The Civil law systems in a comparative perspective

Participants will also choose three electives amongst the five following courses:

- International settlement of disputes
- Industrial and intellectual property
- Comparative Constitutional Law
- Civil liability law in Europe
- International and European Contract Law

As a continuation of the courses, the participants will have the opportunity to meet the representatives of major legal actors, such as lawyers and notaries.

CULTURAL ACTIVITIES

The training is completed by cultural visits of the highest French legal institutions such as the Constitutional Council, State Council, the Cour de Cassation, as well as the parliamentary assemblies, namely the Assemblée Nationale and the Sénat.

REGISTRATION FEES

The registration fees include the classes, conferences, visits and cocktails. For the 2018 edition of the Summer school, the fees are the following:

- 500 € without accomodation / hosting ;
- 1 500 € for the housing / accomodation program for the whole month of July at the International University Campus in Paris (CIUP).

Scholarships can be exceptionally granted upon justified request.

EXAMINATION AND CERTIFICATE

Provided they regularly attend university, the participants will be granted a participation certificate to the Summer School of Continental Law. Students who signed up for the final exam will receive a Civil Law Initiative Certificate delivered by the University Panthéon-Assas Paris II.
