<p>The subject of Criminal Policy is devoted to the analysis and evaluation of theoretical, scientific and practical issues of criminal policy.</p> <p>Topics analyzed: the concept and content of criminal policy; criminalization (decriminalization) and its criteria; penalization (depenalization) and its criteria; the system and types of penalties, the types and structure of sanctions, the sentencing rules, case law, etc. ; factors influencing criminal policy: crime structure and tendencies; influence of the Constitution and decisions of the Constitutional Court on criminal policy; law enforcement and judicial activities; economic and financial capabilities of the state and human resources; the influence of the science of criminal law and criminology on criminal policy, the requirements of international and European Union law on criminal policy, etc.; criminal policy in Lithuania and its historical development; the effectiveness of criminal policy and the criteria for evaluating it; criminal policy in Eastern, Central and Western Europe.</p> <p>Upon completion of the study subject, the doctoral student must have mastered the system of categories of criminal policy, knowledge of how the same categories are perceived and interpreted in legal doctrine, legislative process and jurisprudence. Moreover, the doctoral student must be able to analyze the chosen problem of criminal policy in the broader context of theoretical problems of law, be able to apply various methods of legal research to assess and solve theoretical and practical problems of criminal policy.</p>
