<p>The subject of evidence problems in criminal proceedings is intended to assess the admissibility of data as evidence, theoretical and practical problems of admissibility of evidence, to analyze data collection issues in non-procedural or pre-procedural actions and problems arising from analysis of the use of measures in criminal proceedings.</p> <p>Topics analyzed: the concept of evidence; the problem of the relationship between case data and evidence; criteria for recognizing data as inadmissible (prohibited) evidence; in the process of proving the problem of protection of human rights and freedoms; in the process of proving the rights of the participants in the proceedings; problems of proof in the use of non-criminal data.</p> <p>After completing the study, the doctoral student must be able to examine the chosen problem of evidence in criminal proceedings in a broader context of theoretical problems of law, be able to apply various methods of legal research to assess and solve theoretical and practical problems of evidence in criminal proceedings.</p>
