<p>The subject of problems of the labour law is designed to examine the specific theoretical problems of reforming labour law in general and special part in order to adapt it to new socio-economic living conditions, to bring it into line with international labour standards, as well as European Union law.</p> <p>Topics analyzed: regulatory relations of labour law, relations between labour law and other branches of law, application of the principle of autonomy of the parties in labour relations, place of collective legal regulation in labour law, problems of legal regulation of individual labour law institutes and collective labour law (collective agreement, collective labour disputes information and consultation, employee participation) and in the field of individual labour law (employment contract and its substitutes, working and rest time, remuneration, guarantees and compensation, material liability, disciplinary liability, labour disputes).</p> <p>After completing the study, the doctoral student must have mastered the system of categories of labour law and have knowledge of how the same categories are perceived and interpreted in the doctrine of law, the legislative process and jurisprudence. After completing the study, the doctoral student must be able to analyze the chosen theoretical problem of labour law in the broader context of theoretical problems of law, be able to apply various methods of legal research to assess and solve these problems.</p>
