Themes are dealt with:</p> <ul style="list-style-type: none"> 1) The essence and specifics of the sociological approach in law understanding and analysis; 2) The methodology of a Sociology of Law. 3) recognition of law as a social phenomenon and identification of its connections with other social phenomena. 4) law as a consequence and expression of human sociality and culture (specific societies culture). 5) the reflection of the regularities of society in law (such as stratification, hierarchy and other). 6) the influence of social impact on the perception of legal behaviour, decision-making, legal assessment. <p>After completing the study, the doctoral student will be able to analyze and evaluate the reflections of social regularities in law, analyze the relationship between changes in legislation and the application of law understanding various social aspects (regularities); to understand the influence of various social aspects and social structure on the development of legal thinking.</p>
